 Grace Eckert approached Council stating that she was against the re-zoning of 208 Aiken
 Street. She said she worked a very stressful job and she wanted to keep her neighborhood as it was. She did not want condos or townhomes built right in her back yard.

Eleanor Garrett approached Council stating that she was against the re-zoning to allow townhomes or condos or anything being built on Aike and Pepper Street. She said it was already like a speedway down through there and it did not need more traffic added to it. She said it was dangerous and unsafe with all the traffic and speeding. She asked who she needed to contact about speed bumps. Mayor said he would find out. Paige Bowers asked if she thought a four-way stop may help. She said it would not.

Joseph Bradford approached Council and stated that he did understand the town needs growth but he asked that Council would take in consideration at what rate it was happening. He said he was talking about Aiken Street. He said he didn't understand what had happened on Tarrant Street but it was done. He told Council he did not want them to think he was fussing and he wanted them to think about what rate Central was going to grow.

Kelsey Crooks said she was with the Pickens County Planning Commission. She said she wanted them to think about joining the joint Pickens County Planning Commission. She said she wanted them to keep it transparent and follow the guidelines for annexations.

With no objections, Mayor Andrew Beckner adjourned the meeting.
