D. Recreation - Ken Dill

He said Pete was doing training to repair the equipment and if he works on it, they will pay him and that will go back into the Rec Fund.

PARD Grant Match

Ken Dill made the motion to fund the PARD grant match in the amount of \$4800 from the Hospitality Fund; seconded by Lynne Chapman. The vote was unanimous.

Bike Trail

Ken Dill made the motion to fund the bike trail in the amount of \$4000 from the Hospitality Fund; seconded by Paige Bowers. The vote was unanimous.

E. Enterprise- Harry Holladay

He said the Sanitation Department ran on a normal schedule and 139 work orders were completed. Harry Holladay said they work hard and he appreciates all they do for the town.

F. <u>Tourism and Economic Development – Daniel Evatt</u>

Daniel Evatt made to motion to allocate \$300 a month from Hospitality to fund the Main Street Director Position; seconded by Joe Moss. The vote was unanimous.
