The meeting was called to order by Mayor Andrew Beckner.

Ken Dill rendered the invocation.

Reading of Minutes for Regular Council Meeting Minutes 04.08.2024
Paige Bowers made the motion to adopt readings of Regular Council Meeting Minutes 04.08.2024; seconded by Joe Moss. The vote was unanimous.

Public Session (30 Minutes Total)

Council Member Curtis Peek asked to be excused to speak as a citizen during public session. He said that he had some individuals to approach him about the construction on Lawton Road beginning construction at 6:30 am. He said that we have an ordinance that says construction should not begin prior to 7:00am and the police department had been notified about the incident. He said we should hold Great Southern Homes and their sub-contractors accountable for the failure to follow for ordinance that is on the books. He said the other issues on Lawton Road are the work crews parking on the side of the road, half in the road way and half off the road. He said it is a narrow twolane road which definitely causes a safety hazard. He said with the work crews parking this way is cutting down even more of the roadway. He said that this needs to addressed with Great Southern Homes and their sub-contractors. Curtis Peek said the other issue was about the corner of Pepper Street and Tarrant Street. He said there was an undeveloped piece of property there that is being surveyed. He said just above it were duplexes that have been built and the zoning was not truly looked at when presented to the Planning Commission and Council, so his fear was that it might get overlooked again. He said we need to do our due diligence to hold developers, if they are looking at property hold them accountable for making sure the zoning for their point of view and the towns point of view are the same. He said as for him as a citizen that area is not the place for duplexes or medium density housing.

Dr. Joel Stites approached Council and introduced himself. He is the Head Men's Basketball Coach for Southern Wesleyan University. He said he would like to open up a line of communication between SWU and the Town of Central as far as sports goes. He gave his goals and visions of what the connection could be. He gave his background and wanted to get the community involved. He wanted to create a legacy the Town and SWU could be proud of.

Catherine Whiten approached Council with concerns about her water. She said that it clears up and then goes muddy again. She said it has ruined a lot of clothes, dishes come out dirty after she runs the dishwasher, and when she comes in from working in the yard, she is cleaner than the water she has to take a shower in. She said she had come in and talked to the ladies at the front and she was asked if it was her pipes. She said she came back in on Friday with a sample of her water. She said the front desk made a call and someone came out to flush the hydrant and she had a picture of what was coming out of the hydrant on her phone. She said it was solid red. She said she was told we have been working on the lines but for some reason we had to stop. She said she was having to buy bottled water to cook and drink with. She said it was so expensive each month. She said right now it is wonderful and clear but at any given time it will turn back muddy. Her neighbors were going to join her tonight with the same issues but they had to work late. Mayor Beckner asked her to take his business card. She asked if they wanted to see the pictures. Lynne Chapman said she would. Ms. Whiten showed all the Council Members the pictures.

Planning – Paige Bowers

Paige Bowers reported the Planning Commission would not meet in May due to lack of quorum. They would resume in June.

Streets and Public Safety - Joe Moss

Joe Moss reported the fire department would do a wet down at Central Academy of Arts on May 15th and at Central Recreation after school on May 22nd. He also said they would be assisting in the Car Show May 25th.

<u>Enterprise & Community Engagement – Lynne Chapman</u>

Lynne Chapman reported for the month of March the Water and Sewer Department completed 180 work orders. The meters were read on March 12th. Rechecks were done on the 18th and disconnects were done March 26th. 44 customers were disconnected for non-payment and 37 of these reconnected. The Sanitation Department, both residential and commercial, operated on normal schedules for the month of April.

Recreation - Ken Dill

Ken Dill reported that we would be co-hosting the 8u District Diamond Baseball Tournament June 13-19 at Nettles Park.

Ken Dill reported the 2024 HUK Central Pro Series Disc Gol Tournament was held May 3-5 at the Central Grand Station Disc Golf Course. It consisted of 125 Pro and Amateur Disc Golf Players from around the country. We counted approximately 60 spectators on the course each day following the tournament. We had 98 surveys returned. The player came from 12 states. The average dollars spent on food and lodging was \$282.91 per person. The impact on the local economy was \$27,725 who filled out the survey not

including spectators. 23 players made special trips to tour and visit sites in Pickens County such as Twelve Mile Park, Clemson University, Central Railroad Museum, Downtown Central and Historic Depot, and Botanical Gardens. 58 players visited restaurants in our area for a total of 223 visits to restaurants over a 4 day period.

<u>Finance and Marketing – Curtis Peek</u>

Curtis Peek reported our general fund currently has a balance of \$724,368.96. This is an increase of \$40,995.34. This is an increase of 5.82% in the general fund from March to April. Our Enterprise funds have the following revenues for the month of February and year to date balances.

The water budget for April has a surplus of \$9,067 and for the year we currently have a deficit of \$47,294. This is a decrease of 17.49% in our deficit from March to April.

The sewer budget for April has a surplus of \$27,197 and year to date the sewer account has a surplus of \$150,724. This is an increase of 19.83% in the sewer fund from March to April.

The sanitation budget for April has a surplus of \$6,512 and year to date sanitation account has a surplus of \$59,717. This is an increase of 11.53% in the sanitation fund from March to April.

<u>Tourism and Economic Development – Robert Griffin</u>

Robert Griffin reported the Car Show would be on May 25th and a concert would be the 24th downtown.
