Phillip Mishoe reported that we have an annexation request for 31 parcels. He said that it would be 100% freeholder and were on the agenda.

<u>Planning – Paige Bowers</u>

Paige Bowers made the motion to re-appoint Tripp Brooks and Daniel Bare to the planning Commission; seconded by Mayor. The vote was unanimous.

Streets and Public Safety – Joe Moss

Joe Moss reported had 36 calls in June and assisted Liberty Fire with a structure fire.

<u>Enterprise & Community Engagement – Lynne Chapman</u>

Lynne Chapman reported for the month of June the Water and Sewer Department completed 219 work orders. The meters were read on June 15th. Rechecks were done on the 18th and disconnects were done June 26th. 43 customers were disconnected for non-payment and 33 of these reconnected. The Sanitation Department, both residential and commercial, operated on normal schedules for the month of May.

Recreation – Ken Dill

Ken Dill reported that we are still rehabbing the playing surface at Bolick Field. On July 9th, we will be topdressing the field. We are allowing Cannon Baptist church to use parts of the field for their Bible School since we work together.

Ken Dill reported that after 2 months, Tom Cloer finally has made contact with Norfolk Southern to put forth a plan for public use of the old Central Concrete property. I am working on a proposal for safety fencing to protect the public and other necessary measures to meet their requirements and then we can begin ideas for the public use of the existing property.

<u>Tourism and Economic Development – Robert Griffin</u>

Robert Griffin gave updates on events for the Town of Central as follows:

- *Garden Club meeting 6/24 main goals are to plant former tree planters by fall loosely by September 6th.
- *Date for the Fall Festival is October 26th. A committee will be formed to help steer / plan / fundraise / execute events. We want to bring back the "Railroad Festival" umbrella event that will encompass the Trick or Train kids' portion, plus concerts and day-long activities

*Planning will begin at the end of July for the Daniel / Rec. homecoming parade.
