Reading of Minutes 08-14-2023

Paige Bowers made the motion to adopt Regular Council Meeting Minutes 08-14-2023; seconded by Joe Moss. The vote was unanimous.

Public Session (30 Minutes Total)

Curtis Peek approached Council inquiring about the water flow on Church Street. Phillip Mishoe said that they had to run the water while they are doing the project until it is tied in. This is to prevent bacteria from forming in the lines. Curtis Peek asked if this cost would be passed to the citizens. Phillip Mishoe told him that no it was included in the project. Mayor Beckner thanked him for his concern.

D. Recreation – Ken Dill

Ken Dill reported we experienced our biggest Super Saturday ever. It had to be changed some for the extreme heat. Thanks to everyone and especially the Fire Department and all other volunteers who made this day special.

Ken Dill said the Tiger Mural at Bolick Field overlooking the Central Tigers ballfield has been a huge hit and well received by all, especially the kids. He thanked Sacred Tattoo for the murals.

Ken Dill reported that we have applied for a State Grant to pave the hill on the powerlines to help prevent erosion. The grant will also be used to build handicap sidewalks and transfer ramps to the new playground along with a safety fence enclosure.

E. Enterprise – Harry Holladay

Harry Holladay reported the Sanitation Department operated on a normal schedule. They had 191 total work orders completed for the month of August. They had 29 disconnects with 27 reconnects.

F. Tourism and Economic Development- Vacant

Ken Dill made a motion for a vote of support to allow Administration pursue gift in kind funding for the stage downtown by Lowe's and authorize town administration to name the stage after Lowe's if that is their desire; seconded by Paige Bowers. The vote was unanimous.
